PROGRAM STRUCTURE

- Apply for admission to the Juris Doctor program, then the Master of Business Administration program
- Complete first full year of law school on Mercer's Macon campus
- Enroll in evening MBA courses on Mercer's Macon campus
- Take business and law courses simultaneously during the second and third years of law school
- Apply certain course credits between programs to satisfy both degree requirements
- Complete the combined degree program within three years as a full-time student

ADMISSION

Applicants seeking admission must meet the requirements for both the School of Law and the School of Business. A bachelor's degree from a regionally accredited institution is required for admission to both programs. The Juris Doctor program enrolls students once per year in August, and students begin Master of Business Administration coursework following completion of the first full year of law school. International applicants should consult the University catalog for additional requirements.



- · Completed application
- \$50 non-refundable application fee (\$100 for international students)
- · Official transcripts from each college attended*

*Applicants seeking admission to Mercer's School of Business must be in good academic standing with the School of Law.
